# THE MUNICIPALITY OF NORTH PERTH

## BY-LAW NO. 138-2023

### Being a By-law to provide for various Fees and Charges for the Municipality of North Perth

**WHEREAS** Section 391(1) of the *Municipal Act, 2001, S.O., 2001, c.25*, as amended, authorizes a municipality to impose fees and charges on persons for services or activities provided or done by or on behalf of it, for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board, and for the use of its property including property under its control;

**AND WHEREAS** Section 391(2) of the *Municipal Act, 2001, S.O., 2001, c.25*, as amended, states that a fee or charge imposed for capital costs related to services or activities may be imposed on persons not receiving an immediate benefit from the services or activities but who will receive a benefit at some later point in time;

**AND WHEREAS** Section 391(3) of the *Municipal Act, 2001, S.O., 2001, c.25*, as amended, states that the costs included in a fee or charge may include costs incurred by the municipality or local board related to administration, enforcement and the establishment, acquisition and replacement of capital assets;

**AND WHEREAS** Section 391(4) of the *Municipal Act, 2001, S.O., 2001, c.25*, as amended, states that a fee or charge may be imposed whether or not it is mandatory for the municipality or local board imposing the fee or charge to provide or do the service or activity, pay the costs or allow the use of the property;

**AND WHEREAS** Section 391(5) of the *Municipal Act, 2001, S.O., 2001, c.25*, as amended, states that in the event of a conflict between a fee or charge by-law and the *Municipal Act, 2001, S.O. 2001, c.25*, as amended, or any other act or regulation made under any other act, the by-law prevails;

**AND WHEREAS** Section 69(1) of the *Planning Act, R.S.O. 1990, as amended*, states that the council of a municipality, by by-law, and a planning board, by resolution, may establish a tariff of fees for the processing of applications made in respect of planning matters, which tariff shall be designed to meet only the anticipated cost to the municipality or to a committee of adjustment or land division committee constituted by the council of the municipality or to the planning board in respect of the processing of each type of application provided for in the tariff;

**AND WHEREAS** Section 69(2) of the *Planning Act, R.S.O. 1990, as amended*, states that despite a tariff of fees established under subsection (1), the council of a municipality, a planning board, a committee of adjustment or a land division committee, in processing an application, may reduce the amount of or waive the requirement for the payment of a fee in respect of the application where the council, planning board, or committee is satisfied that it would be unreasonable to require payment in accordance with the tariff;

**AND WHEREAS** Section 7(1)(c) of the *Building Code Act, 1992, S.O. 1992, c. 23*, as amended, states that the council of a municipality may require the payment of fees on applications for and on the issuances of permits, requiring the payment of fees for maintenance inspections, and prescribing the amounts of the fees;

**AND WHEREAS** Section 7(2) of the *Building Code Act, 1992, S.O. 1992, c. 23*, as amended, states that the total amount of the fees authorized under section 7(1)(c) must not exceed the anticipated reasonable costs of the principal authority to administer and enforce the *Building Code Act, 1992, S.O. 1992, c.23*, as amended, in its area of jurisdiction;

**NOW THEREFORE** the Council of the Municipality of North Perth enacts as follows:

1. The following schedules apply to various services provided by department:
  - i. Schedule "A" Corporate Services Fees
  - ii. Schedule "B" Development and Protective Services Fees
  - iii. Schedule "C" Public Works Fees
  - iv. Schedule "D" Environmental Services Fees
  - v. Schedule "E" Facilities Department Fees
  - vi. Schedule "F" Programs Department Fees
2. Interest on any outstanding fees will be charged to the person at a rate of 2% per month. If this amount remains outstanding at the end of the calendar year, pursuant to Section 398 of the *Municipal Act, 2001, S.O. 2001, c.25*, it may be added to the tax roll of the property to which the service or thing was supplied or in all other cases, property for which all of the owners are responsible for paying the fees and charges and be collected in the same manner as municipal taxes.
3. Council will review the fees and charges when deemed appropriate.
4. This by-law comes into force on January 1, 2024.
5. By-law 160-2015, as amended, is hereby repealed.
6. This By-law shall be known as the "Fees and Charges By-law"
