## THE CORPORATION OF THE TOWN OF NORTH PERTH

## BY-LAW NO. 128-AD-2000

BEING A BY-LAW OF THE TOWN OF NORTH PERTH TO PROHIBIT THE THROWING, PLACING OR DEPOSITING OF REFUSE OR DEBRIS ON PRIVATE OR MUNICIPAL PROPERTY.

WHEREAS Section 210, subsection 82 of *The Municipal Act* R.S.O. 1990 gives municipalities the authority to pass by-laws for prohibiting the throwing, placing or depositing of refuse or debris on private property or on property of the municipality or any local board thereof without authority from the owner or occupant of such property;

**AND WHEREAS** the Town feels that there is a need for such a by-law in order to maintain the visual appeal of the Town on both public and private property;

**NOW THEREFORE** the Council of the Town of North Perth enacts as follows:

- 1. No person shall throw, place or deposit refuse or debris on private property or on property of the municipality of any local Board thereof without authority from the owner or occupant of such property.
- 2. Any person who contravenes any provisions of this by-law is guilty of an offence and upon conviction shall be subject to a fine as provided in *The Provincial Offences Act*, R.S.O. 1990, chapter P.33 as amended.
- 3. This by-law shall come into effect on the date of passing thereof.
